Tuesday, February 28, 2020, 6:30 PM Condon Center, 2nd Floor Conference Room Chaminade College preparatory, 23241 W. Cohasset St., West Hills, CA 91304

Numbers refer to agenda items:

- 1. Committee Co-Chair Brad Vanderhoof called the meeting to order at 6:31 PM. Those in attendance: Faye Barta, Tom Booth, Dan Brin, Jessica Fuentes, Heidi Manning, Olivia Naturman, Steve Randall, Tony Scearce, Ron Sobel, Joan Trent, and Brad Vanderhoof. Absent were Tony Brosamle, Kian Gholibiek and Myrl Schreibman. A quorum was established. Stakeholder Glenn Jennings also was present.
- 2. The January 28, 2020 minutes were approved as amended.
- 3. Comments from the Chairs: Faye B. discussed a suggestion from Heidi M. about trying to get more Board members to attend the cleanups to help with various tasks, other than actually cleaning up, such as manning the table where snacks and drinks are served, monitoring sign-in of volunteers, distributing tools to volunteers and putting tools back into Ron's van, and filling out service credit letters. Brad V. said that the co-chairs are also tasked with getting tools and sundries from both the Montessori storage shed and the Orcutt Park shed, and then taking tool and sundries back after the cleanups. Faye also discussed Heidi's idea about scoping out the area chosen for cleanup at least two weeks before the scheduled event to choose an appropriate meeting place.
- 4. Public Comment: none
- 5. Review of February, 2020, cleanup: Both Brad V. and Faye B. felt the February cleanup went very well, even with a smaller number of volunteers who worked very hard to finish up all the cleanup. They also commented on how much food and water the hospital donated and actually sent a few volunteers as well. Olivia N. mentioned that because the area of cleanup was so spread out, there might be a better co-ordination of where to pick up and return the tools closer to where volunteers were working.
- 6. Discussion and Reminder of March 28, 2020 cleanup: The 03/28/2020 cleanup will be on Valley Circle Blvd. between Victory and Woolsey Canyon. Both Brad V. and Faye B. will scope out the area at least two weeks before the cleanup to determine which area needs cleanup most so that Dan B. can prepare the flyer. The most likely meeting place could be Lazy J Park.
- 7. Discussion and possible action on partnering with West Hills/Canoga Park Chamber of Commerce: Faye will again try to contact Joellen at the Chamber to try to set up a cleanup partnering for a future cleanup.
- 8. Discussion and Possible Action on progress of scheduling volunteer groups for cleanups: Heidi M. is still working with giving dates and times to scout troops, but will need to know future cleanup dates. She will also contact Reseda High ROTC and Tony S. will supply a contact name for Heidi. Tony S. needs flyers for Hale's bulletin boards. Ron S. suggested getting our flyers out to HOA associations and will try to do so with his own HOA. Jessica suggested spreading the cleanup information by word-of-mouth to neighbors and friends. Heidi M. also suggested leaving flyers at all neighborhood watch meetings at the Topanga station and combining other activities, like shredding trucks and electric waste collection to cleanups.
- 9. Discussion and possible action on ROW letters: There were no suggestions this month.

- 10. Discussion and possible action on spending request for 2019/2020 budget: Dan B. and Ron S. suggested blowers would make cleanup easier. Steve R. moved to purchase two blowers in a sum not to exceed \$300.00. Joan T. seconded. The motion passed unanimously.
- 11. Discussion and possible action on committee budget for 2020/2021: Faye B. announced that last year we requested and got a budget of \$3,500. Steve R. moved to ask for a budget of \$3,500 for 2020/2021. Ron S. seconded. The motion passed unanimously.
- 12. Discussion and possible action regarding abandoned newspaper vending machines on sidewalks: Brad V. reported the machine he reported was still in place. Heidi M. reported her submission was still pending. Brad V. and Steve R. suggested they would remove those boxes in front of the post office because the businesses which left them had gone out of business.
- 13. Discussion and possible action on dates and sites for cleanup and food costs for July 2020 through December 2020: This item was tabled.
- 14. Strike Team Reports: Dan B. is still tearing signs down. Steve R. removed an overhanging branch which was assaulting cars passing it by. Jessica picked up two cartons of discarded cigarette butts in her neighborhood. Heidi M. is still picking up dog poop and properly disposing of it.

Committee Co-chair Brad Vanderhoof adjourned the meeting at 7:30 PM.
