JOINT BEAUTIFICATION COMMITTEE/BOARD ONLINE AND TELEPHONIC DRAFT MEETING MINUTES

Tuesday, October 19, 2021 @ 6:00 PM

Numbers refer to agenda items:

- 1. Committee Co-Chair Brad Vanderhoof called the meeting to order at 6:03 PM. The meeting was recorded. Those in attendance: Faye Barta, Dan Brin, Glenn Jennings, Heidi Manning, Steve Randall, Anthony Scearce (left the meeting at 6:30 PM), Myrl Schreibman, Joan Trent, and Brad Vanderhoof. Absent was Tariq El-Atrache.
 - Also present were Bonnie Klea and Christina Walsh.
 - A quorum was established.
- 2. The September 21, 2021 minutes were approved as amended.
- 3. Comments from the Chairs: Faye advised that Kian Gholibeik has resigned from this committee. Brad asked if anyone would like to become a new member or know anyone who would like to be a new member. There were no responses.
- 4. Public Comment: None.
- 5. Discussion and Possible Action on Cleanup Events for October 30, November 20 (Environmental Awareness Day), December, 2021, and suggestions and dates for 2022.
 - Faye advised that she spoke by telephone with Edgar Fuentes, Acting Park Maintenance Supervisor at Orcutt Ranch Park, to let him know the committee will be cleaning up the park fencing along March Avenue and Justice Street at Orcutt Ranch Park on October 30, 2021. Mr. Fuentes was very happy to hear that. Faye reminded the committee that on November 20 we will be tabling at Environment Awareness Day at Chatsworth Train Station and will inform the public about what the Beautification Committee is and what we do, and we will be handing out flyers, coffee mugs, WHNC bags and pens. Steve reminded the committee that we had voted to paint hydrants for the December 11 cleanup, but perhaps that would be cancelled. Dan suggested we use the December 11 date to finish the unfinished part of Fallbrook between Ingomar and Saticoy from our August cleanup. Heidi suggested we clean up the cul-de-sac on the east side of Mae Boyar Park. Brad suggested we reconsider the December cleanup at the November meeting. He also suggested we pick 2022 dates at our November meeting.
- 6. Discussion and Possible Action on creating a community garden; report on progress on "paper street" with Lee's office by Brad and Steve; possibility of other locations.

The community garden was discussed briefly at last month's meeting. Bonnie said that UCLA's study regarding The Santa Susanna incident warned that there should be no garden within a two-mile radius. Christina said the pie lot across from Chaminade could be made into a garden, including food plants. Steve advised that the pie lot is being reviewed by Councilmember Lee's office and will check on that office's progress on the issue. Brad advised Ron Rubine was working on making the pie lot a pollinating park and will check on the status of that suggestion. Christina said that a bag of pollinator seed bombs could be used on the Saticoy lot because it contains many different kinds of seeds, and that such a bag will be available at the November event, and that getting mulch is available. Faye reminded everyone that the Saticoy lot has no source of water. Heidi said water could be trucked in.

- 7. This item is a duplicate of #6.
- 8. Discussion and Possible Action on Creation of a Pocket Park or Parklett Related to LADOT Livable Streets Projects:

Brad advised this project seeks to make streets more friendly, and there already is one on Rinaldi. Christina advised the best plantings are native plants, similar to the Platt Field. Dan commented that there is an access problem with Platt Field. Dan also commented that just as with a paper street, a pocket park must be discussed with and agreed to by neighbors nearby. Dan also said he thinks the corner of Valley Circle and Roscoe, where the art wall project is proposed, would be ideal for a pocket park. Brad suggested that the area at the intersection of Sale and Marlin behind Shadow Ranch Park, because there are no buses there. Brad also suggested a tree canopy on the Platt islands. Christina believes before any new trees are put on the Platt islands, the City must have a specific request to remove the old and dead trees, otherwise the canopy will not survive. Heidi advised that where there are presently dead tree stumps, our committee could prepare and distribute a flyer on "how to order a new tree from the City". Brad said that information for ordering and receiving a tree could also be put on social media and flyers. Joan warned that some City trees have and/or create problems and cost money, so to be careful not to plant invasive trees. This matter is tabled to the November meeting for more information.

9. Discussion and Possible Action on a West Hills "Best Garden Contest" or "Landscaping Contest":

Faye stated this topic might be better to reconsider in the spring. This matter is tabled to January, 2022.

10. LA City Park Maintenance Updates, Including Reports from members regarding conditions of our local parks:

Brad said Rec and Parks is really badly pressed for personnel, so this matter would be better to consider at the beginning of next calendar year. This matter is tabled to January, 2022.

11. ROW Letters:

Brad advised that ROW letters are most successful immediately after delivery. However, after the homeowners initially take care of the problem, they usually repeat their old bad habits of not taking care of the problem.

Heidi advised that on March Avenue at Ingomar, the detritus has been taken off the sidewalk but only put onto the parkway on Elkwood. Brad will check on the letter sent to the homeowners and advise. There were no other suggestions for ROW letters.

12. Strike Team Reports:

Steve reported that he cut overhanging branches of a neighbor's pine tree.

Dan reported that he removed many signs.

Heidi reported she called 311 to collect the palm fronds on March and the fronds were collected.

Steve reported that on Eccles, four large trees blew over and were removed, but one tree remains and needs to be removed. So he sent a message to John Lee's office about that remaining tree.

Christina advised to take a grocery bag with you when you walk, with a message on the bag to properly dispose of trash, and pick up and remove whatever trash you can.

No one had any comments about this agenda item. It is tabled to November.

14. Suggestions for the November Agenda:

Heidi suggested we partner with Zoning and Planning, since that committee voted not to request the City install restrooms in the parks, to suggest something else to put into our parks, for example, shade structures, artificial grass. Heidi also mentioned that Lazy J needs more picnic tables with shade, either from trees or umbrellas. Christina said she supports picnic tables.

Myrl asked if the City will install restrooms even if Zoning and Planning does not want them? No one had any answer.

Brad asked if anyone had any park improvement suggestions. Joan said more seating would be good. Heidi suggested we should revisit this item to November to give the committee time to think of other improvement suggestions.

Myrl said there is only one picnic table at Castle Peak and more are needed there.

Myrl also reminded the committee that on November 6, John Lee's Office is sponsoring a drive-in movie night at Shadow Ranch Park and will show "The Wizard of Oz". Since there is availability for only 100 cars, reservations must be made with Lee's Office. Myrl also suggested the committee and/or the Board can have a booth or table there. Myrl also advised Wendy's is providing free food.

Christina inquired what committee is responsible for trails and stated that the Dayton Canyon trail remains unfinished.

Dan said Zoning and Planning should make Pulte live up to its promise about Dayton Canyon. Dan also advised that the movie event is an annual event and WHNC always tables.

Heidi inquired about a horse trail. Christina advised there is one on Roscoe west of Valley Circle.

Brad adjourned the meeting at 7:19 PM.
