# **OPENING BUSINESS**

President and Co-Chair Dan Brin called the meeting to order at 7:10 p.m. Secretary Nicole Flessati called roll and announced an initial attendance of 21 board members, establishing a quorum. Vice President and Co-Chair Charlene Rothstein led the Pledge of Allegiance. September 2015 meeting minutes were approved.

# **COMMENTS FROM THE CHAIR**

President Dan Brin announced that Elliot Maggin has resigned from the board and subsequently there is a vacant board seat. Simone Best and Nicole Flessati have been appointed as Co-chairs of the Communications committee. This year's Fall Fest was a success with a great turn-out. He thanked all the board members that came out to man the WHNC's booth.

#### **ANNOUNCEMENTS**

CD 12 – John Lee, Chief of Staff for Councilman Englander with Ron Rubine, Field Deputy, who discussed the Constituent Care Center and drone regulations (no fly zone within 5 miles of airports and adhering to the FAA regulations). There is an effort to pass an ordinance regarding street racing. John Lee discussed Devonshire PALs and Topanga PALs (youth centers). Their mission is to foster relationships between the youth in the area and the LAPD. They are always looking for resources in the way of donations. He also announced a program to engage local schools and students. They will in turn hold a film festival to show the student-produced films.

CD12 is also hosting a drive-in movie night at Shadow Ranch Park.

Regarding the Haynes Street Bridge, City Attorney Mike Feuer has said it will be re-opened. More details will be available at a later date.

The new Senior Lead Officer for North West Hills, Sean Brown, introduced himself. # **NEW BUSINESS**

15-0049 – Discussion and possible action regarding the appointment of a candidate to the WHNC board. Candidates were able to present themselves to the board, after which each of the board members made a vote for their candidate choice. Candidates present were:

**Agenda Item 15-0051** - Discussion and possible action regarding a proposed resolution calling for an updated SSFL health risk assessment. Alec Uzemeck made the motion to vote on this proposed resolution. Steve Randall suggested a friendly amendment. Alec accepted friendly amendment. Public discussion took place before the board discussion. There were many comments on both sides of the argument to support this resolution. **Vote was taken and passed with 14 yes votes, 6 no votes, 1 abstention and 1 ineligible.** 

**Agenda Item 15-0052** - Discussion and possible action regarding the WHNC Standing Rules in reference to removal and/or censure of a board member. TABLED

**Agenda Item 15-0053** – Discussion and possible action on approving the use of The Web Corner for creating a new web site for the WHNC for a total of \$2,000. A vote was taken and **motion passed with 19 yes votes, 1 no vote and 2 ineligible.** 

**Agenda Item 15-0054** – Discussion and possible action on approving allocating \$150.00 per month for maintenance of the new website by the Web Corner for the period of December 2015 through June 2016 for a total cost of \$1,050.00. **Vote was taken with 20 yes votes and 2 ineligible. Motion passed.** 

**Agenda Item 15-0055** – Discussion and possible action on approving a Neighborhood Purpose Grant to Friends of Shadow Range and Woodland Hills Parks, Inc. in the amount of \$1,298. This funding will come out of the \$2,4000.00 already approved by the board for the 4<sup>th</sup> annual West Hills Fall Fest. Board member Bob Brostoff recused himself for the vote. A vote was taken and **passed with 18 yes votes, 1 NO vote.**

# **Proposed Friendly Amendment**

# **HEALTH RISK RESOLUTION**

The West Hills Neighborhood Council (WHNC) is a body of the City of Los Angeles established under the Los Angeles City Charter. Our 25-member Board of Directors is elected by the community to represent approximately 42,000 stakeholders and advise other elected officials and departments.

The West Hills community is located close to the Santa Susana Field Laboratory (SSFL), making the pathways of human exposure from SSFL-related contaminants a major public concern. Most of the test data that are available are 10-20 years old and the residents living within close proximity to the SSFL have the right to know the current level of potential off-site impact.

It is the responsibility of the WHNC to acquire and disseminate credible current information. Evaluating the current risks to health from radioactive and chemical contamination at the SSFL is imperative, enabling the WHNC to provide the facts to the public.

Therefore, the WHNC recommends that the ATSDR, under the guidance of the Centers for Disease Control and Prevention (CDC), re-evaluate the data and determine the current health risks related to the SSFL.

# Standing Rules re: Censure/removal

# Article V, Governing Board, Section 8/9 Censure or Removal of Governing Board Members

All proposed changes are in **bold italics** or **bold strikeout**.

Procedures for submitting petitions

- A. A petition must describe in detail the reason(s) for censure or removal as defined delineated in Article V, Section 8/9
- B. <u>All petitions shall be submitted to the president and vice president, who shall</u> The president and vice-president verify that the petition is based upon one of the 3 reasons allowed, as defined delineated in Article V, Section 8/9, paragraph D of the bylaws and that, if submitted by a stakeholder, the required minimum 50 signatures are on the petition.
- C. <u>If verified</u>, A <u>a</u> complete copy of the <u>signed written</u> petition shall be provided to the subject board member(s) within 10 5 (five) days of receipt by the <u>board president or vice</u> <u>president</u>. Any notice given by mail shall be sent by <u>first class registered</u> mail <u>with proof</u> <u>of delivery</u> to the <u>Director</u> member's (s) at his or her last known address.
- D. The president and vice president shall first attempt to mediate the issues.
- E. An informal meeting of the president, vice president, petition author(s) and the named board member(s) shall take place within 15 days of notification to the named board member(s) to try and attempt to resolve the issues presented in the petition.
- F. If this mediation is successful, no further action will be taken.
- G. If this mediation is not successful, the following steps will be taken:
  - 1. The president or vice president shall seek advice of the City Attorney and EmpowerLA.
  - 2. A mediation or facilitation shall be requested through EmpowerLA.
  - 3. If this mediation or facilitation shall does not take place within 30 days of the request, or if the mediation/facilitation is not successful for any reason the following steps will shall be taken:

4.

a. if If it the petition was submitted by a board member, a special meeting of the board shall be scheduled called Within within 15 days from the failure of the mediation for the purpose of the petitioner presenting their case, obtaining the 13 required board signatures on the petition, and proceeding with discussion and possible action.

- 1. The petitioner(s) shall present their case, which may include documents and witnesses.
- 2. The named board member shall present his/her case, which may include documents and witnesses
- b. If the petition is submitted by a non-board member, the a special meeting will only shall be scheduled only for discussion and possible action
  - 1. The petitioner(s) At the special meeting, advocates shall present their case; which may include discussion, and possible action documents and witnesses.
  - 2. The named board member shall present his/her case, which may include documents and witnesses.
  - 2.-Any censure or removal of a Director pursuant to this subsection shall require an affirmative vote of two-thirds (2/3) of the Directors present, and no fewer than 13 affirmative votes excluding the vote of the Director being considered for removal or censure.
- I. The subject shall be given a minimum of fifteen (15) business days prior to notice of the Board meeting at which the matter is to be discussed and voted on.
- A. The ad hoc committee referred to in Article V, Sections 8/9, Paragraph C shall take evidence regarding the petition, including giving the individual the opportunity to appear and present testimony and other evidence in her/his defense. The committee then shall make a recommendation to the Board for action.
- B. The ad hoc committee shall make its recommendation to the board within 30 days of receiving the petition for removal.
  - 1. The recommendation shall be placed on the agenda of the next regular Board meeting.
  - 2. The Director shall be given an opportunity to be heard, either orally or in writing, at that Board meeting, and to present testimony and other evidence in her or his defense. Upon a showing of good cause, the Board may vote to grant a continuance of the meeting for a period of not less than fourteen (14) days or more than thirty (30) days.
