OPENING BUSINESS:

President and Co-Chair Dan Brin called the meeting to order at 7:05 p.m. Secretary Carolyn Greenwood called roll and established quorum.

December 6, 2018 minutes approved as amended.

19-0001 – Discussion and possible action regarding approval of the WHNC's November 2018 Monthly Expenditure Report (MER).

Monthly expenditure report was approved with 19 yes votes, two (2) abstentions and three (3) absent.

Controller Anthony Brosamle explained the Controller's Report. Mr. Brosamle said we have entered the second half of the budget year and yet some committees have not expended any of their budgeted funds.

COMMENTS FROM THE CHAIR

There were no comments from the chair.

ANNOUNCEMENTS:

Senior Lead Officer (SLO) Kari McNamee spoke about the latest statistics for the Topanga Division. Officer McNamee stated that overall the crime rate has dropped 5% during 2018. Officer McNamee went over a breakdown of the various types of crimes. Personal theft and other theft are still high.

Semee Park, standing in for Kathleen Quinn, DONE Neighborhood Council Advocate, asked questions related to the upcoming elections for the WHNC. Ms. Park advised that the focus for the next few months would be the elections.

Scott Abrams, director of Congressman Sherman's Constituent Services Office, spoke about the congressman's upcoming Town Hall Meeting on Saturday, January 19. Mr. Abrams also advised that January 11 is the deadline for those affected by the Woolsey Fire to apply for FEMA assistance. People are encouraged to apply even if they don't currently think they need the assistance.

COUNCIL ANNOUNCEMENTS

Education – The committee is working on the educator and staff awards. Hope to be able to announce winners in May.

Homelessness – January 22 is the West Hills Homeless Count. Please sign up online. The committee's meeting dates are changed for the next two months. The next meeting is January 14 and the February meeting will be on the 11th.

Streets and Transportation – The next meeting is on January 21. The committee is continuing to work on solutions to reduce street racing and speeding. It will also discuss the program to paint utility boxes with traffic safety messages.

Events Committee – The committee is working on another "active shooter" event.

Public Safety & Emergency Preparedness – The committee is working on dates for two events.

Zoning & Planning – At its next meeting, the committee will discuss Malibu Wines & Beer Garden.

Environment Committee – The committee next meets on Wednesday, January 9 to discuss the possible effects of the Woolsey Fire at the SSFL site.

Beautification – The committee's next meeting is on January 21. A cleanup in the Fallbrook/Victory area will occur on Saturday, January 19.

CERTIFICATES OF APPRECIATION

Certificates of appreciation were presented to Terri Fox of Foxy and the Hounds, Sandy Spees, Diane Pfeifer and Barbara Vasilaros for their tireless efforts on behalf of displaced and homeless animals.

PUBLIC COMMENT

There were no public comments on non-agenda subjects.

BOARD ANNOUNCEMENT

Co-Chair, Dan Brin announced that this is the beginning of the 30-day period to apply for the position vacated by Simone Best due to her move to Palm Desert. He added that a Certificate of Appreciation for her service will be mailed to Ms. Best.

Mr. Brin stated that this is the appropriate time to speak about another item on the agenda:

19-0002 – Discussion and possible action of facts pertaining to Ivan Blume's absences, leading to a possible announcement of a vacancy.

Mr. Brin explained that according to our Bylaws a board member is subject to removal after having more than four (4) absences in a 12-month period. Mr. Brin stated that records indicate that Mr. Blume has missed five (5) meetings in the last twelve-month period. Mr. Blume confirmed that the records are correct. Mr. Brin then announced with regret that the seat is therefore vacant. In discussion, Board Member Myrl Schreibman expressed his disagreement with the attendance provisions in the Bylaws.

Mr. Blume was presented a Certificate of Appreciation for all of his work with the Board. He then left the room.
