## FINAL BOARD MEETING MINUTES February 7, 2019

#### **OPENING BUSINESS**

President and Co-Chair Dan Brin called the meeting to order at 7:02 p.m. Acting Secretary Brad Vanderhoof called roll and established quorum.

Vice President and Co-Chair Charlene Rothstein led the Pledge of Allegiance.

Minutes of the Jan. 6, 2019 meeting were approved.

**19-0005** – Discussion and possible action regarding approval of the WHNC's December 2018 Monthly Expenditure Report (MER).

Monthly expenditure report was approved with twenty-one (21) yes votes and two (2) absent.

Controller Anthony Brosamle presented the Controller's Report. Three of the 2019 Education Neighborhood Purpose Grants (NPGs) have been funded and the other eight have been sent to the City Clerk. He reminded the Council of the urgency to spend remaining funds.

Bob Brostoff presented the Budget Committee Report. To date the WHNC has spent 25% of its 2018-2019 budget.

#### **COMMENTS FROM THE CHAIR**

Co-chair Dan Brin stated the LAPD Senior Lead Officers are unable to attend the meeting because it is the 10h anniversary of the Topanga Station and they are preparing for a formal inspection on Jan. 7. Dan read crime statistics provided to him by SLO Sean Brown. Northern West Hills is seeing an increase in residential burglaries while thefts from vehicles are up in Southern West Hills.

#### **ANNOUNCEMENTS**

Ron Rubine, District Director for Council District 12, spoke about the transition from Mitchell Englander to interim Councilmember Greig Smith and said it would be mostly business as usual at the CD12 office. There will be a Conversations with Councils on Feb. 25 at New Horizons and all board members are welcome. In response to a question, Mr. Rubine said he would investigate the threat of typhus in the San Fernando Valley. There will not be a "Making Movies that Matter" youth film festival this year.

Kathleen Quin from the Department of Neighborhood Empowerment said candidate filing is open for the WHNC election. There will be a candidate information presentation on Saturday, Jan. 9, at "The Onion" in North Hills.

Blake Clayton, Field Deputy for Supervisorial District 3, said the County is looking to build a homeless shelter in Canoga Park but no plans have been finalized. There will be two meetings to discuss a Canoga Park bridge housing proposal: Feb. 12 from 6:30 to 8 p.m. and Feb. 22 from 9 to 10:30 a.m. at the Canoga Park Community Center. There are currently no locations under consideration in West Hills.

Janis Risch, Adult Literacy Coordinator for the Los Angeles Public Library, described the Career Online High School Program. The program is open to all City of Los Angeles residents and employees and takes between five and 18 months to complete. Upon graduation, participants receive an actual high school diploma and not a GED. There have been 200 graduates to date.

#### **COUNCIL ANNOUNCEMENTS**

**Youth & Education** – Aida Abkarians announced the Educator Awards will be discussed on Feb. 15. The Committee is planning an anti-bullying forum for the fall of 2019. The Pomelo robotics team finished first in the state.

**Homelessness** – Olivia Naturman said the committee meeting will be a week early this month and feature a presentation on bridge housing. Thomas Booth said the 2019 Homeless Count was a great success and the results will be available in June.

**Events Ad Hoc** – Myrl Schreibman said there will be another "active shooter" presentation in March and the hope is to include actual survivors.

**Streets and Transportation** – Steve Randall said he is working to address the dip on Roscoe near Fire Station 106. Anthony Brosamle said the small asphalt repair truck will be in West Hills on Feb. 19 and committee members have created a list of locations for it to visit.

**Public Safety and Emergency Preparedness** – Bob Brostoff said the committee is planning a meeting with residents of the new development at the north end of Fallbrook to discuss Neighborhood Watch and disaster preparedness.

**Zoning & Planning** – Bill Rose said the committee will meet on Feb. 12 and there are several interesting items on the agenda.

**Environment** – Alec Uzemeck said the committee will meet this month.

**Public Health** – Sandi Bell said she is working on a resolution concerning immunization exemptions.

**Beautification** – Faye Barta announced the next cleanup event will be on Feb. 9.

Government Relations – Joanne Yvank-Garb announced Zach Volet will be the new co-chair of the committee. There will be a Budget Day in the San Fernando Valley, on a Saturday sometime in March. Exact date TBD.

Charlene Rothstein and Aida Abkarians presented certificates of appreciation to Ed Peisner and Tim Jaffe from the Organization for Social Media Safety for their work to end bullying in schools. They also will receive a commendation from the City of Los Angeles. February is Social Media Awareness month in the city. Mr. Jaffee announced the 2019 Peace and Kindness Music Festival will be on May 4.

#### **PUBLIC COMMENT**

Earl Gomberg, Regional Director, of Adult+Pediatric Urgent Care, presented an overview of the services available at the facility in West Hills.

Glenn Bailey said there will be a homelessness solutions forum on Feb. 16 at Granada Hills High School. Mr. Bailey also urged everyone to save the date, Saturday, Sept. 28, for the Congress of Neighborhoods. On Sunday, March 17, from 10 a.m.-2 p.m., there will be a celebration for the 80<sup>th</sup> anniversary of a plaque commemorating the Stagecoach Trail in the Santa Susana State Historic Park. Meet at Chatsworth Park South. Mr. Bailey also said a Board of Neighborhood Commissioners ad hoc committee is reviewing the guidelines for neighborhood council alliances and he believes the process should be more transparent with NCs having a voice.

Danny Hirsch, de Toledo High School history teacher, introduced the de Toledo Speech and Debate Team. Mr. Hirsch described an effort to have March 1 declared National Speech and Debate Day and asked for support from the WHNC. de Toledo debate team sophomore captain Benny Greenspan and team members Hannah Baron and Bradley Gerber described what speech and debate mean to them and how the team experience has affected their lives. The team is heading to Stanford for a tournament.

Four candidates for the L.A. City Council District 12 special election spoke: Dr. Loraine Lundquist, Annie Cho, John Lee, and Scott Abrams.

The West Hills Neighborhood Council (WHNC) hereby advises that it OPPOSES the Proposed Ordinance set forth by the Department of City Planning (DCP) in City Council File 12- 0360-S4 and will be filing a Community Impact Statement (CIS) shortly in opposition thereto.

WHNC's CIS will contain, among other items, the following points:

- The 948-page Proposed Ordinance is misleading; it definitely is not just an administrative reorganization of existing ordinances, as DCP claims it to be.
- What the Proposed Ordinance actually does is to delegate and remove or shift away from the City Council a broad array of authority over planning and land use, completely in violation of provisions of the City Charter, specifically Sections 556 and 558. None of the findings required by the Charter can be made on this record.
- The Proposed Ordinance is not merely procedural; it is most definitely substantive. It purports to incorporate and permit "state law" to set parameters for authority and delegation of authority to the Mayor and the unelected Director of Planning, who is appointed by the Mayor, rather than the provisions of our City Charter and Los Angeles's status as a Charter City. The seemingly casual references to (/state law" are in effect an erosion of our status as a Charter City and the control that a Charter City has over large and major parts of its own destiny to the state. In effect, (/state laws" are merely default provisions of the Government Code, which otherwise would not apply to, or would apply differently to, Charter Cities.
- The Proposed Ordinance delegates many planning decisions to the Mayor or to the appointed (by the Mayor) Director of Planning, without preserving both the right to appeal to City Council and the City Council's ability to step in and remove a matter from Planning, as is currently provided for in the City Charter. This proposed delegation of planning decisions not only eliminates appeal rights and abilities to remove a matter from consideration, but also it fosters the appearance of impropriety. Equally important, the Proposed Ordinance removes notices and rights to public hearings for most people and for City-certified Neighborhood Councils, which are currently provided for in the City

Charter. In effect, this takes Planning back to the days when planning was performed between developers and mayors in smoky rooms and behind closed doors.

- The Proposed Ordinance makes decision-making ministerially or administratively complete with minimal public notice and minimal public hearing and minimal right of appeal, if any. For example, public notice to residents within 500 feet of a proposed project and neighbors across the street and to certified Neighborhood Councils, which is presently REQUIRED by the City Charter, early warning system of Section 907, has been completely removed and replaced with notice only to immediately adjacent neighbors, thereby totally eliminating Neighborhood Councils.
- Although the DCP states the Proposed Ordinance merely standardizes and streamlines the
  processes and procedures of planning, it is actually an attempt to refocus almost all power
  and authority away from the public and Neighborhood Councils to the Mayor and his
  appointed Director of Planning, all in direct opposition to the provisions of the City
  Charter.

Please consider this opposition and do not consider the Proposed Ordinance for approval without extending the response period for at least 120 more days for additional opposition and CIS to be filed.
