

Article V, Section 6: Vacancies on the Board

Vacancies on the Board shall be filled using the following procedure:

- A. When a vacancy is created on the Board, a notice shall be posted immediately on the WHNC website, and it shall be announced at the next regular Board Meeting by posting a notice in a public place, by sending an email via the WHNC email list, and by announcing it at the next board meeting.
- B. Any qualified Stakeholder interested in filling a vacant seat on the Board shall submit an application to the Secretary within 30 days after *announcement Posting* of the vacancy. at a Board Meeting. Such application forms may be available on the WHNC website or may be obtained by written request to the secretary of the WHNC.

Amendment 4.

Section 7: Absences

A Board Member who has been absent from one-third (1/3) five (5) of the regular or special meetings of the Board within the most recent twelve (12) month period shall be subject to removal from the board under procedures established by the Board. A Board Member may for good cause, request a leave of absence not to exceed three (3) months, subject to the approval by a majority of the Board. Nonattendance during an approved leave of absence shall not be counted as absences under the terms of this section.

Article V, Section 6: Vacancies on the Board

Vacancies on the Board shall be filled using the following procedure:

Amendment 4.

Section 7: Absences

A Board Member who has been absent from one-third-(1/3) five (5) of the regular or special meetings of the Board within the most recent twelve (12) month period shall be subject to removal from the board under procedures established by the Board. A Board Member may for good cause, request a leave of absence not to exceed three (3) months, subject to the approval by a majority of the Board. Amendment 5.

Article VI Officers of the Board, Section 2: Duties and Powers, Paragraph E. The Controller

- 1. Shall maintain an inventory of all assets and properties of the WHNC
- 2. Shall conduct quarterly audits of all financial records and submit the results of each audit to the Board within thirty (30 days of completion of such audit when possible.
- 3. Shall conduct an audit of the budgeted expenditures of all committees monthly.
- 4. Shall prepare written reports of such audits providing the original budgeted amount for each committee and the current balance of those budgets.
- 5. Shall submit the audits to the board quarterly.
- 6. Shall be a member of the Budget Committee

Note: When this amendment is adopted by the board, the numbering will be revised by deleting paragraph 2.
