As of now, that is a 2/3 majority of Board seats (17 yes votes for the WHNC to take action). That is being contested by the Valley Alliance of Neighborhood Councils (VANC).

One proposal is to require Board meetings to be held in public, with a possible consideration to allow Board members to participate remotely in a maximum of two meetings per calendar year.

Another proposal lets committee chairs determine whether to meet in public or virtually.

Under current procedures, hybrid meetings for the public are allowed and up to the discretion of committee chairs.

Board meetings currently have a hybrid component for the public.

This will undoubtedly be a complex discussion. All opinions are valued; please treat one and another with respect.

5. Discussion of Possible Future Agenda Items for the Bylaws Committee Adjournment

The next meeting of this committee is scheduled on Tuesday, December 26, 2023, at 7:30 PM. This meeting is subject to cancellation.

Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, an issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to two minutes per speaker, unless adjusted by the presiding officer of the committee.

Co-chair Brad Vanderhoof called the meeting to order at 6:40 PM. A quorum was established.

Numbers refer to agenda items.

- 1. Approval of the September 2023 Committee Meeting Minutes: Minutes approved as amended.
- 2. Comments and Announcements from the Chair: Brad said the committee should finish writing proposed Bylaws amendments by December. That would allow time for a first reading in January, a Board vote on individual amendments in February, and a Board vote on the submission package for DONE in March. That package is due by April 1, 2024.
- 3. Public Comment: Jeff had a question on why minutes from September are not posted yet. The September minutes were approved at this meeting and will be posted.
- 4. Use of WHNC Logo on Correspondence:

Proposed;

Article V: Duties and Powers of Board Members Board members including officers shall not claim to be, or give the impression of, speaking or communicating by any means on behalf of the WHNC without approval from the Board. Board members including officers shall not make any representations, requests, or agreements, on behalf of the Board, without approval from the Board. This includes the use of WHNC letterhead and the WHNC logo.

Steve moved to include the above into the WHNC Standing Rules. Carolyn seconded.
