JOINT HOMELESSNESS COMMITTEE/BOARD MEETING MINUTES

JUNE 15, 2020

Telephonic and Web Meeting

Revised June 18, 2020

Those in attendance: Aida Abkarians, Thomas Booth, Olivia Naturman, Brad Vanderhoof, Dan Brin, Cinnamoo, Kian Gholibeik, Corinne Ho, Marie Javdani, Saif Mogri, Steve Schutzhah, Joan Trent, Joseph Vargas, 818 ***983.

Committee Co-chair Olivia Naturman called the meeting to order at 6:03 PM. A quorum was established. The minutes from the February meeting were approved with a correction to the spelling Smilaick.

Numbers refer to agenda items.

4. Chair Comments: Olivia said she is glad meetings have resumed. Aida reported the NPGs for emergency relief were approved.
5. Homeless Liaison: Marie said the homeless liaisons have not met and do not have a meeting scheduled.
6. Public Comment: Steve Shutzah, a local business owner, spoke about a construction site at 7621 Canoga Avenue. He feels the efforts to minimize disruption to neighboring businesses are inadequate. This will be added to the July agenda. Corinne announced an Ad Hoc Covid19 Recovery meeting will be held Sunday at 1:00 PM.
7. Discussion and possible action on approving Budget for Fiscal Year 2020-2021: Olivia presented a budget request for the 2021 Homeless Count.
Aida moved to approve. Joan seconded.
The motion passed unanimously.
8. Report on 2020 Homeless Count Results: Marie gave a report on the results released by LAHSA.
LA County had a 12.7% increase in individuals experiencing homelessness.
LA City had a 14% increase in individuals experiencing homelessness.
LA needs housing.
African Americans make up 8% of the general population and 34% of the homeless population.
An average wage of \$41.96/hour is needed to afford housing.
9. Discussion and possible action on updated emergency bridge housing to CD 12: Thomas showed a copy of the proposed letter.
10. Discussion and possible action on linking services to high profile, high emergency: The speaker planned for the meeting was not available. This will be rescheduled.
11. Update on positive local events, people and solutions related to homelessness: Thomas presented the WHAVNA project list.
12. Update, discussion and possible action on supportive housing, bridge housing, and alternative housing options: Item tabled to July.
13. Call for future agenda items: None.

Committee Co-chair Olivia adjourned the meeting at 7:00 PM.

Dear Council Member Lee:

The recently released 2020 LAHSA Homeless Count Report reveals a 19% increase in homelessness in LA County - SPA 2 since 2019¹, exacerbated by COVID-19 and the current economic recession. Though Council District 12 has begun to fulfill its 222 bed pledge, it is behind all other council districts' pace. With only eighty beds in the Canoga Park housing facility in Council District 3, and with emergency housing slated to close in a few months, a more robust and urgent plan to build permanent housing units is required in the West Valley. The continued growth of those living unhoused is putting our entire community at risk.

The current housing crisis demands innovative short-term and long-term solutions. In the immediate future, we respectfully propose an extension and expansion to the temporary shelters and a navigation center to provide relief for our unhoused neighbors who require shelter with proper social distance. Due to the high cost and time of building these shelters, bold leadership is needed in support for innovative, expedient, and affordable options such as Pallet Shelter housing on city or county-owned land. For the longer term, we request the creation of further bridge housing in CD 12, similar to plans in Council Districts 2, 3, and 7.

A person experiencing homelessness and living without shelter is in immediate danger. The mortality rate of people experiencing homelessness in Los Angeles is more than double that of the general population.² Each day there is an average of three deaths of unhoused people in Los Angeles. The number of deaths annually of unhoused doubled from 2013 to 2018, with more dying from COVID-19 in the past four months. Additionally, black people are four times as likely to experience homelessness³ and an increased death due to racial inequalities in housing and the health-care system. Providing shelter immediately will reduce costs of the current high utilization of emergency services being provided, decrease public safety risks and, most importantly, give safe harbor for those in need of housing.

We appreciate your leadership and pledge our commitment of support in reaching these humanitarian goals of equity and ending homelessness for the benefit of our entire community. Please act now to address this ongoing crisis and suffering by directing the creation of further interim and permanent supportive housing in Council District 12.
