Committee Co-chair Aida Abkarians called the meeting to order at 6:00 PM. A quorum was established.

The August meeting minutes were approved.

Chair Comments: Aida said thirteen individuals experiencing homelessness in West Hills have been identified as being in need of mental health services.

Public Comment: Sandra Dye spoke on life experience while experiencing homelessness.

Meeting recording started.

Numbers refer to agenda items.

- 6. Pursuing different ways and new ideas of helping our unhoused population: Steve discussed tiny homes. Kent spoke on the Judge Carter decision. Tiffany Franklin spoke on housing inventory, and said homelessness is becoming a public health issue. Sandra Dye described problems with Project Room Key. Tiffany Franklin described the Coordinated Entry System.
- 7. Finding ways to help students who are homeless: Aida presented a document from UCLA, *State of Crisis; Dismantling Student Homelessness in California*. Myrl will contact UCLA for more information and a possible speaker for a future meeting.

Committee Co-chair Aida Abkarians adjourned the meeting at 7:14 PM.
