Please note that under the Ralph M. Brown Act, the committee is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, the issue raised by a member of the public may become the subject of a future committee meeting. Public comment is limited to 2 minutes per speaker, unless adjusted by the presiding officer of said committee.

Notice to Paid Representatives: If you are compensated to monitor, attend, or speak at this meeting, City law may require you to register as a lobbyist and report your activity. Wednesday, November 1, 2022 @ 7:00 P.M.

The October 10, 2022 minutes were approved as amended by unanimous consent.

Comments from the Chair(s): Steve Randall stated that the Halloween event was a huge success.

The 2023 Senior Valentine's Day Dinner Dance was discussed. Char stated that she is awaiting a confirmation on the availability of the Bob Hope Center at Chaminade for Tuesday, February 14th. Rosi advised that Calvary Church was not a viable option as the room was too small. Steve stated that John Lee is available that day. The budget was discussed and the budget in the amount of \$3,875 was approved by unanimous vote.

Myrl stated that the 2022 Halloween Event was a success. Alejandro stated that there were 2,871 views of the houses on our web page and 414 views of the winning houses. Many people visited the homes, some coming from neighboring areas, and that they especially appreciated the live actors at some sites. Myrl mentioned the KTTV news coverage and that Alejandro took some incredible drone footage. Also, that the donated trophies and winner's certificates were to be delivered during the weekend, that the winners appreciated the Winner's Lawn Signs. Alejandro both posted and hand delivered the map with a QR Code to his child's school, that was successful in promoting the event.

Myrl advised that we will be needing to change the date for the 2023 Kids' Day Event due to a conflict with the Spring fest event at Shadow Ranch Park.
