## PREVENT AUTO CRIME LOCK IT! - HIDE IT! - KEEP IT!



#### **VEHICLE THEFT**

All Hyundais, Kias, and older model pick up trucks and SUVs are targeted for vehicle thefts. There is also a high demand for the parts of these popular cars. However, car thieves will take any car they can get, so please use precautions to help deter theft.

- Always Take Your Keys & Lock Your Car! even if you are just pumping gas or running inside somewhere really quick. Thieves are watching and waiting for these opportunities. And if you "Tandem" park, thieves know to look for the other car's keys in your vehicle, or vice-versa. So please don't keep keys in the car
- Use a Security System these can include: Audible Alarms, Steering Wheel Locks/Clubs, Ignition and/or Fuel "Kill Switches", Hood Locks, etc.
- Install a Tracking Device if your car is stolen, a Vehicle Recovery System may help in finding your car more quickly and assist police in catching the suspects.

#### THEFT FROM VEHICLES

Thieves will break car windows and pry open doors for as little as some loose coins visible in the center console. Even more attractive to thieves are purses, backpacks, cell phones, laptops, etc. that are left in plain sight. They even like to take personal documents and mail that they can use to commit identity theft. Anything with the slightest value that can be traded for money or drugs is what thieves want and will take. And if you leave your car unlocked, it's that much easier for them.

- Please be sure to lock your doors, and please take your property with you. If you can't take your property with you, make sure to lock it in the trunk or hide it.
- Other tips: Use a car alarm, park in well-lit areas, place tracking devices on your property,
  install security and/or doorbell camera at your residence. Use anti-theft screws on your license
  plates, and cross-cut your registration tabs to prevent theft.
- Theft of Catalytic Converters Install Catalytic Converter cages or screens and etch your vehicle vin number onto the Catalytic Converter.

### PUBLIC SAFETY & EMERGENCY PREPARDNESS COMMITTEE OPERATING RULES

Revised September 20, 2023 April 17, 2024

The MISSION of this Committee is to:

- A. Interface with the Los Angeles Police Department, the Los Angeles Fire Department, hospitals and other agencies on matters relating to the safety of the Stakeholders.
- B. Assist stakeholders in organizing such groups as Neighborhood Watch and Map Your Neighborhood (MYN/RYLAN)
- C. Conduct forums on public safety and emergency preparedness.

These rules may be amended at any regular meeting of the Committee by a majority vote of the members present provided possible action on the committee operating rules is announced in the agendawith the exception of rule 5.

- 1. The Chair(s) of the Public Safety & Emergency Preparedness Committee are: Chair Saif Mogri
- 2. Additional officer(s) appointed by agreement of the Chair(s).
  - a. Secretary:none
- 3. Members of this committee shall be appointed or removed by agreement of the Chair(s).
- 4. WHNC Board members and WHNC stakeholders are eligible to serve on this committee.
  - a. The committee members are FayeBarta, Clarice Chavira, Saif Mogri, Steve Randall, Randhara Kotuwelle, Joe Ourfalian and Brad Vanderhoof
- 5. A quorum shall consist of a simple majority of the total number of committee members.
- 6. Voting rights shall be accorded to committee members only.
- 7. For this committee "serving actively" is defined as participating in a minimum of one committee events per calendar year (if held).
- 8. The writing and posting of agendas shall be the responsibility of the Chair.
- 9. The taking and posting of minutes shall be the responsibility of the Cha.
- 10. Committee members must not miss more than four (4) meetings in a 12 month period, or they may be subject to removal from the Committee.
- 11. Committee members including officers shall not claim to be, or give the impression of, speaking or communicating by any means on behalf of the WHNC without approval from the Board.
- 12. Committee members including officers shall not make any representations to or requests of the Board or any other agency, on behalf of the Committee, without approval from the Committee.
- 13. The parliamentary process is to be governed by "Rosenberg's Rules of Order: Simple Parliamentary Procedures for the 21st Century."
- 14. All meetings, discussions, and communications pertaining to the business of this committee shall be conducted in compliance with the Brown Act.
- 15. This committee shall abide by the WHNC Code of Civility. This code shall apply to all committee members, whether they are members of the WHNC Board or not.
- 16. This committee will meet on the 3<sup>rd</sup> Wednesday of the month at 6:30 PM unless rescheduled.
