Committee Co-Chair Tony Brosamle called the meeting to order at 6:41 PM. A quorum was established.

The December 2016 meeting minutes were approved as amended.

5. January 21st Cleanup: Tony mentioned the need for more loppers and traffic cones.
6. Next Two Months' Cleanup Projects: The February cleanup event is scheduled for Saturday, February 18, 2017 from 8:30 to 11:30 AM at Shoup Ave. and Saticoy St. Meeting place is the northeast corner of Shoup and Saticoy. Steve commented on the need to advertise outside. Heidi suggested more social media outreach to churches, schools, and other organizations. Olivia offered to work on getting coffee and organizing an outreach table at the next event. Tom and Olivia will work on getting information about cleanup events to the faith-day occult. The following suggestions were made for the March event; Dan – Platt from the hill to Haynes, Tony – Medical Center Dr., Reeyan – Platt near Taxco Trails Park, Valley Circle near Stagg and Dorie, the north side of Roscoe across from Orcutt Ranch, Hillary, Barry – Valley Circle medians near Victory and especially at the West Hills welcome sign. By consensus the group selected the median islands along Platt as the location and March 18, 2017 at 8:30 AM as the date and time for the March Cleanup event. The meeting location is to be determined.
