- 1. Meeting was called to order at 8:00 p.m.
- 2. Quorum was established. Simone Best, Tony Brosamle, Dan Brin, Steve Randal, Alec Uzemeck and Brad Vanderhoof were present. Bob Brostoff was absent. Stakeholders Janis MacQuoid and Reeyan Raynes were present.
- 3. The 11/15/17 minutes were approved with minor changes.
- 4. Comments from the Public were made by Janis who stated how impressed she was by the actions of the committee, and former Board Member Reeyan Raynes who noted that the usual committees still have not posted their minutes.
- 5. There were no comments from the Chair.
