Committee Co-chair Anthony Brosamle called the meeting to order at 7:35 PM. A quorum was established.

The June meeting minutes were approved as amended. The August meeting minutes were approved.

Public Comment: None

Chair Comment: Olivia Naturman announced she must step down as committee co-chair but will remain active.

Numbers refer to agenda items:

5. Utility Box Art Project: Olivia presented artwork submitted by Aida Abkarians. The Department of Neighborhood Empowerment is checking her eligibility. There are two other applicants.

Steve moved to extend the application deadline to November 15. Myrl seconded.

Olivia added a statement that all applicants must have a full-size mockup ready for the December committee meeting.

6. LADOT Livable Streets: Olivia presented LADOT's livable streets program. The website is live at ladotlivablestreets.org or ladot.lacity.oeg

7. Safety Fair: Thermo-Fischer has agreed to provide a location. Myrl said the WHNC must purchase insurance because the event will be held on private property. The event is planned for March 2020.

8. General Updates: Tabled to November.

9. E-Scooters: Marie said there are many regulations for e-scooters. Brad suggested they are new to the West Valley and being ridden as a novelty or toy. Brad also said scooters should have automatic led lights. Myrl would like to get the opinion of the LAPD SLOs before continuing discussion. Bonnie said Simi Valley has banned e-scooters. Anthony B. asked a link to scooter regulations be placed on the WHNC webpage. Myrl suggested posting to the West Hills CA Facebook page. Anthony B. suggested posting as individuals. Marie suggested inviting an e-scooter vendor to the safety fair.

10. Parking on Valley Circle: Tabled to November.

11. Measure A Competitive Grant Funding: Tabled to November.

12. Protective Left Turn Signal at Platt and Highlander: Tabled to November. This will be a priority. Please provide suggestions of other problem intersections to the co-chairs.
