This meeting of the Public Health Committee was conducted online via Zoom webinar and Telephonically.

Committee Chair Sandi Bell called the meeting to order at 3:55 P.M.

Committee members in attendance were: Sandi Bell, Stephen Bell, Steve Randall, Joan Trent, and Henlie Sakamoto. Others in attendance were Brad Vanderhoof. Committee Members absent were Aida Abkarians.

A quorum was established.

The minutes from September 22, 2021 were reviewed and approved as amended.

Comments from the Chair: Char Rothstein sent request from student from CAL State LA to recruit stakeholders for year-long program to mitigate the effects of Diabetes Type 2 with prescribed life style changes. Sandi Bell thought that may be a project of interest to new Youth Advisory Committee.

Sandi Bell mentioned an email from a stakeholder stating that a local business was denying entrance to patrons wearing masks. Sandi Bell stated that she referred the stakeholder to the Public Health Department website to file a complaint and Sandi Bell forwarded complaint to a representative from John Lee's office.

Sandi Bell addressed the mosquito problem in the West Valley. Sandi Bell stated that she will inquire if Mosquito Abatement Program involves releasing sterile male mosquitos to lessen infestation.

There was discussion regarding a letter from the West Hills Neighborhood Council to all City Council Members, in opposition of extending the date for mandatory vaccination of the city employees, i.e. LAFD and LAPD. A vote on the amended letter was approved with 4 yes and 1 abstention.

There were no Public Comments.
