# **Old Business**

- Mae Boyer Park Petition in works via Stakeholder Bonnie Johnson. Steve K. followed up on Tony's initial follow-up. Tabled until petition is in hand.
- Campaign for NW Signs Ivan's follow-up work with the approximated 8 Stakeholders did not provide next steps as a result of names/contacts dating back to 2016. Names to be melded into current data base.
- El Escorpion Park Stakeholder emailed to Steve K. multiple pictures and videos of Park. Stakeholder (Anne Marie L Yantos) is aware that different pictures need to be sent painting a much different picture. Dan (in conjunction with Stakeholder efforts) to Spearhead a "Graffiti Strike Force" to address next steps to be shared with Captain Albert Torres (Park Rangers) and SLO Kari McNamee.
- Transient Encampment on Sherman Way Discussed Reeyan Rayne's "Draft" letter (sent to Steve K.) with letter scheduled to be sent to Enid Gomes (GSD Real Estate Division / City Hall). Brad indicated that Agenda item has been addressed to our satisfaction. Follow-up via Beautification Committee meeting slated for 6/27.
- LAPD Citizens on Patrol /Volunteer Surveillance Team Tony spoke abut 6/23 training at Topanga station. Opening still exist and Tony prompted participation and communication with LAPD contact.

- Vicky Ave. Neighborhood Watch Sign Application. Therese Li spoke about on-line application (in hand for all to review. Rick Yalem supported Therese in discussion. Tony made a Motion to approve the Application...and Dan Seconded the Motion. Application was unanimously approved. Brad to install based upon supply (washer)inventory.
- Sheryl Aldrich (Valley Circle NW) spoke about the newly formed NW and the geographic makeup of the homes (79). Sheryl ordered 100 signs (\$10/piece) via LAPD and request was approved via Captain Ryan. Steve K. has asked SLO Sean Brown about the availability of same signs (N/C)...anticipating follow-up form SLO Brown. Brad asked about specific locations for the 3 approved signs...with Bob to follow-up with Brad. Brad to contact Sheryl for installation particulars.
- Scam & ID Theft event Bob is point-person for the event...and is coordinating speakers/food/etc. Ad has been placed (\$200 Board approved) with Warner Center News. Dan reported that there have been 1,243 "hits" via Social Media. Volunteers identified advised of 6 PM arrival at venue. Sheryl Aldrich to coordinate bulk of food pick-up with Bob. Bob advised that with budgetary timing in play, Michelle has been working diligently to address outstanding event needs.
