SB 411 Updates -If a Neighborhood Council has a quorum of board members in a physical location, board members who wish to join the meeting via teleconferencing must adhere to AB 2449 rules and regulations. If a Neighborhood Council does not have a quorum of board members in a physical location, they must adhere to SB 411 rules and regulations.

In the event of a disruption that prevents the eligible legislative body from broadcasting the meeting to members of the public using the call-in option or internet-based service option, or in the event of a disruption within the eligible legislative body's control that prevents members of the public from offering public comments using the call-in option or internet-based service option, the eligible legislative body shall take no further action on items appearing on the meeting agenda until public access to the meeting via the call-in option or internet-based service option is restored. Actions taken on agenda items during a disruption that prevents the eligible legislative body from broadcasting the meeting may be challenged pursuant to Section 54960.1.

The eligible legislative body shall not require public comments to be submitted in advance of the meeting and shall provide an opportunity for the public to address the legislative body and offer comments in real time. Notwithstanding Section 54953.3, an individual desiring to provide public comment through the use of an internet website, or other online platform, not under the control of the eligible legislative body, that requires registration to log in to a teleconference may be required to register as required by the third-party internet website or online platform to participate.(i) An eligible legislative body that provides a timed public comment period for each agenda item shall not close the public comment period for the agenda item, or the opportunity to register, pursuant to subparagraph, provide public comment until that timed public comment period has elapsed.(ii) An eligible legislative body that does not provide a timed public comment period, but takes public comment separately on each agenda item, shall allow a reasonable amount of time per agenda item to allow public members the opportunity to provide public comment, including time for members of the public to register pursuant to subparagraph (D), or otherwise be recognized for the purpose of providing public comment.(iii) An eligible legislative body that provides a timed general public comment period that does not correspond to a specific agenda item shall not close the public comment period or the opportunity to register, pursuant to subparagraph (D), until the timed general public comment period has elapsed.

Public Input - Comments from the public on agenda items will be heard only when the respective item is being considered. Comments from the public on other matters not appearing on the agenda that are within the Board's jurisdiction will be heard during the General Public Comment period. Please note that under the Brown Act, the Board is prevented from acting on a matter that you bring to its attention during the General Public Comment period; however, an issue raised by a member of the public may become the subject of a future Board meeting. Public comment is limited to two minutes per speaker, unless adjusted by the presiding officer of the committee.

The Committee shall take official action by a simple majority of yes and no votes cast by the committee members present at a duly noticed regular or special Streets and Transportation Committee meeting, not to include abstentions. There shall be no proxy voting.

Attendance: Faye Barta, Heidi Manning, Steve Randall (virtual), Brad Vanderhoof, and Zhelbert Zohrabian.

Absent: Myrl Schreiberman

Other Board members in attendance: Glenn Jennings, and Kim Koerber

Guests: Sean Nagle

Chair Brad Vanderhoof called the meeting to order at 7:30 PM. A quorum was established.

Numbers refer to agenda items.

1. Possible Action to Allow Committee Members to Attend this Meeting Virtually under provisions of AB2449: There was no objection to allowing Steve Randall to attend virtually.
2. Comments from the Chair: None
3. Approval of August Meeting Minutes
4. General Public Comment: None
5. Basset Street Resurfacing: still no action.
6. Visibility Issues in the Proximity of Saticoy and Ingomar: Committee members said they do not see a problem different from all intersections. No action taken.
7. CIS for Council File 24-1009, Single-use Visitor Sticker / Reusable Visitor Tag / Unnecessary Debris (Krekorian - Padilla): After discussion, Steve Randall moved to have an opposition position to the Council File. There was no second. No action was taken.
8. CIS for Council File 23-0002-S152, AB 1082 (Kalra) / Eliminate Parking Enforcement Programs / Manage Curb Space (Lee – Park – De Leon): Introduced August 27, 2024 and referred to Rules, Elections and Intergovernmental Relations Committee. Resolution is requesting that the City of Los Angeles include in its 2023-24 State Legislative Program OPPOSITION to AB 1082 (Kalra) that would eliminate a number of parking enforcement programs used to manage curb space. CIS in support:

The motion passes and will be sent to the Board.

9. Traffic Signal Timing at Roscoe and Fallbrook: General consensus is the situation has improved. Traffic is

still heavy, but the signal timing seems to be okay. Item dismissed without prejudice.

10. Bike Lanes on Topanga Canyon Blvd. from Mulholland to the 118: Best information we have says this is not funded. No action taken.

11. Suggestions for Next Meeting: Zhelbert had two suggestions. First is a four way stop at Victory and Lederer. Second is a study for the traffic signal at Platt and Haynes.

Sean Nagle was added as a committee member by Chair Brad.

Chair Brad Vanderhoof adjourned the meeting at 7:58 PM.

The next meeting of this committee will be on November 19 at 7:30 PM, Chaminade High School.

RESOLUTION

WHEREAS, California Vehicle Code Section 22507 authorizes cities to restrict the parking of vehicles, including but not limited to, vehicles that are six feet or more in height, on identified City streets during certain hours; and

WHEREAS, the Los Angeles Municipal Code Section 80.69.4 allows the Council to authorize by resolution, the streets upon which the parking of oversize vehicles shall be restricted between 2:00 a.m. and 6:00 a.m.; and


WHEREAS, areas in the North San Fernando Valley are experiencing public safety issues associated with large vehicles that are parked overnight and block travel lanes, thereby creating hazardous conditions;

NOW, THEREFORE BE IT RESOLVED, that the City Council, pursuant to the Los Angeles Municipal Codes Section 80.69.4, hereby prohibits the parking of vehicles that are in excess of 22 feet in length or over 84 inches in height, during the hours of 2:00 a.m. and 6:00 a.m. along the following street segments:

- Both sides of Saticoy St. from Woodlake Ave to Fallbrook Ave
- Both sides of Los Alimos St. east of Owensmouth Ave.
- Both sides of Yolanda Ave. from Plummer St. to Citronia St.
- West of Lindley Ave. to the driveway at the end of 18143 Lemarsh St.

BE IT FURTHER RESOLVED that upon the adoption of this Resolution, the Department of Transportation be directed to post signs giving notice of a "tow away, no parking" restriction for oversized vehicles, with the specific hours detailed;

BE IT FURTHER RESOLVED that the Department of Transportation be authorized to make technical corrections or clarifications to the above instructions in order to effectuate the intent of this Resolution.
