Announcements:

Ron Rubine, Senior Advisor, CD12, said there is increased funding for police patrols at shopping malls. The 7th annual Making Movies that Matter show is in one week. Councilmember Lee presented a motion to get E-Bikes off equestrian trails. There will be increased enforcement and penalties for DUIs. There is a motion to allow impoundment of vehicles involved in illegal dumping. An increase from 500 feet to 1000 feet in the zone around schools where encampments are prohibited is proposed.

Vincent Autiero, Neighborhood Empowerment Advocate, DONE, said the Mayor's Budget has been released and includes funding for hybrid NC elections. DONE has asked for additional funding to help with new ADA compliance requirements. The department is looking for ideas on promotional swag.

Secretary Brad Vanderhoof called roll and an in-person quorum was established.

Vice President Aida Abkarians led the Pledge of Allegiance.

Approval to allow Board Member(s) to attend the WHNC Board Meeting virtually under the provisions of SB707: No Board Members attended remotely.

The March meeting minutes were approved.

Senior Lead Officer Report: SLO Dinse said West Hills North had a 34.8% reduction in year to date crime for both violent and property crimes. West Hills South saw a 25% reduction in violent crimes, and a 35% reduction in property crimes (overall a 35% reduction). He said the Topanga Division drone program has been a success and has led to arrests. The Fallbrook Mall has new ownership – Perform Properties. Shadow Ranch Park has a new director. As of March 23, unarmed model response teams are responding to mental health crisis calls. They are dispatched by 911 for non-violent incidents. On June 3, Topanga Division will host a town hall meeting at West Valley Christian Church.

26-0023 - CIS in support of CF 20-0190, Armed While on duty / Park Rangers / Los Angeles Municipal code (LAMC) / Section 63.41 / Amendment (Lee - McOsker): SLO Dinse said he is in favor of this and answered questions.

Saif Mogri moved to amend the CIS to recommend a policy and procedure to have Park Rangers carrying firearms to have body worn video cameras. Aida seconded.

Vincent Autiero, Neighborhood Empowerment Advocate, DONE, said the Mayor will release her budget on April 20. There has been a reduction in stall of three NEAs. Budget Day is June 27 at City Hall. The EmpowerLA youth conference is back for 14-17 year olds. The WHNC Bylaws have been approved. The new Zoom license fee is \$255.61 and needs to be on the next agenda. The department is looking for ideas on promotional swag. The Congress of Neighborhoods Planning Committee has a survey for NC members.

President Rothstein said the Zoning and Planning Committee meeting has been rescheduled to April 21 at 6:30 PM and will be held at de Toledo. This overlaps the Beautification and Streets and Transportation Committees meetings. Brad Vanderhoof said those meetings are therefore cancelled.

Daniell Vicente, Field Representative, LA County Supervisorial District 3, wished a happy Passover. The Metro Board approved the Line K expansion. The price gouging action has been extended 30 days with an exemption for hotels. A motion by Supervisors Horvath and Barger proposes health care reform for the unhoused that involves bringing care to the street. The County is adopting a consistent plan for red flag days.

Presentation : - Beautification of Platt



Platt Avenue Green Street Initiative

Key Benefits

Enhanced Value & Quality of Life:

By transforming a concrete divider into a landscaped amenity, the project directly enhances the daily experience of adjacent residents. A greener, cooler, and well-maintained streetscape serves as a positive asset that can increase local property values.

Environmental Resilience:

Integrates climate-appropriate planting and stormwater capture elements to manage runoff and directly combat the urban heat island effect.

Active Transit & Safety: Naturally calms traffic while creating a shaded, comfortable, and inviting environment for pedestrians and cyclists.

Maintenance Efficiency: Swaps nuisance maintenance (like trash and weed removal on bare paving) with purposeful green infrastructure.

A Corridor of Missed Opportunities

The existing multiway boulevard medians on Platt Avenue are currently liabilities rather than assets.

Public Safety: Wide, unobstructed paved medians create a “speedway” effect, encouraging higher speeds and reducing pedestrian safety.

Operational Burden: These neglected spaces collect litter and weeds, requiring high-cost, reactive maintenance.

Environmental Impact: Expansive pavement contributes to the Urban Heat Island effect and offers zero stormwater management.

Neighborhood Character: The current state of disinvestment diminishes local property pride and corridor identity.

The Vision: Green Infrastructure

This initiative shifts the median from a “leftover” space to a purposeful public asset.

Core Objectives

Manage Stormwater: Capture and infiltrate runoff using bioswales.

Cool the Corridor: Increase canopy cover to reduce surface temperatures.

Standardize Aesthetics: Create a cohesive, memorable visual identity for the neighborhood.

The Strategy: Safety Through Design

Instead of relying on signs that drivers often ignore, this project uses environmental psychology to calm traffic. The “Visual Friction” Principle: Planting trees along a median creates a perception of a narrower roadway. This “optical narrowing” forces drivers to instinctively slow down and increases driver attentiveness by introducing visual complexity.

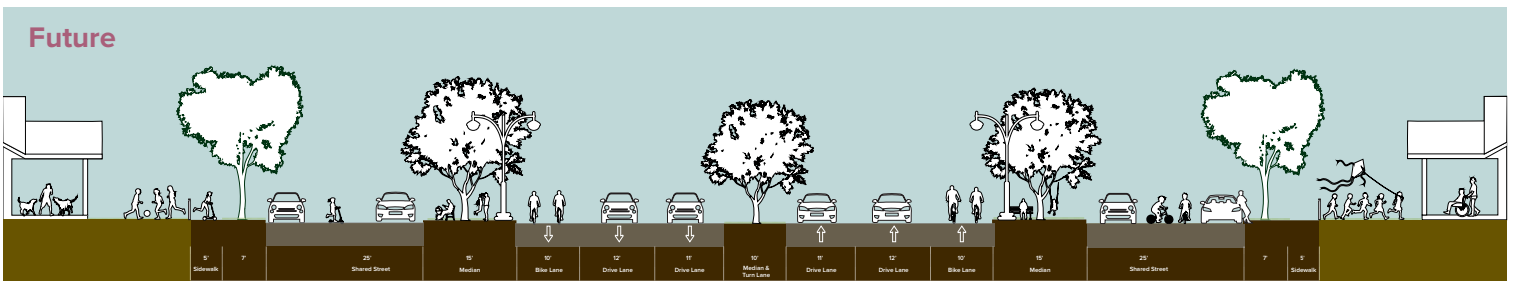
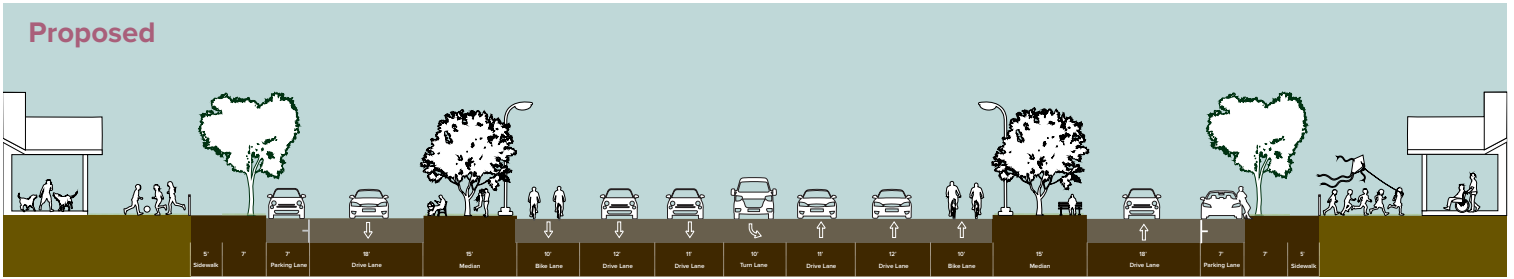
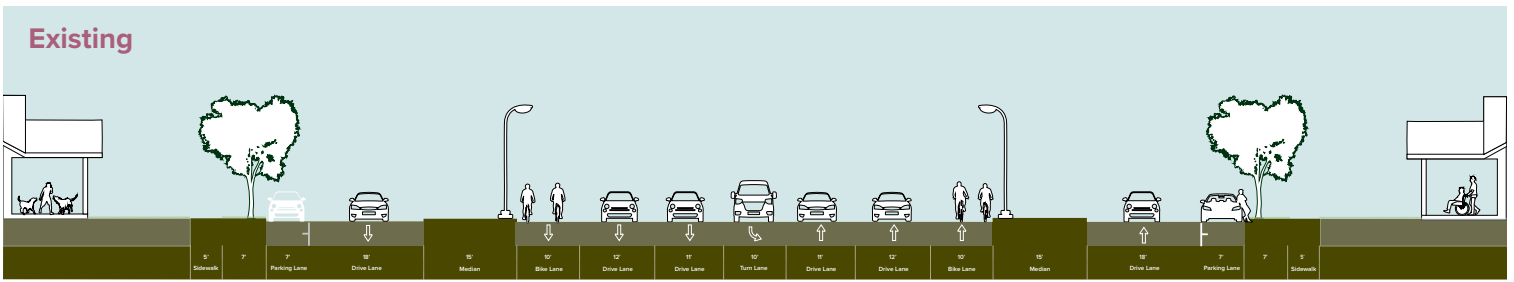
Pilot: Calvert St. to Sylvan St.

This segment will serve as a Proof of Concept to evaluate:

Species Performance: Which drought-tolerant plants thrive with minimal input.

Infrastructure Integration: How stormwater features interact with existing utilities.

Maintenance Costs: Establishing a predictable, proactive care model.



Implementation Roadmap

The Implementation Roadmap establishes a structured framework for transforming the Platt Avenue medians into a functional “Green Street.” It delineates a four-phase process progressing from technical analysis and stakeholder coordination to the implementation of a pilot segment. This phased methodology ensures the systematic integration of environmental resilience, public safety, and long-term operations and maintenance requirements into the project’s design and execution.

	Milestone	Key Focus
1	Technical Assessment	Conduct utility mapping and drainage analysis to ensure green infrastructure like bioswales can safely integrate with existing underground services and manage stormwater runoff.
2	Community Engagement	Gather stakeholder input to build local consensus, ensuring the vision for a “human-scale” connectivity meets the neighborhood’s needs.
3	Inter-Agency Alignment	Coordinate with Public Works and Green Street programs to align technical policies and safety standards across different city departments.
4	Phased Pilot Delivery	Executes a proof-of-concept between Calvert St. and Sylvan St. to evaluate drought-tolerant species performance and establish predictable maintenance costs.

Commitment to Stewardship

Maintenance is a design feature, not an afterthought. To ensure long-term success, the project will utilize:

- Climate-Appropriate Planting: Reducing water demand and pruning frequency.
- Durable Materials: Selecting hardware and layouts that resist wear and facilitate easy cleanup.
- Defined Responsibility: Establishing clear mandates for irrigation and litter control from day one.

Conclusion

The Platt Avenue Initiative offers a scalable, cost-effective solution to enhance public safety, ecological health, and community identity. By transforming neglected medians into purposeful assets, the project replaces liabilities with vital green infrastructure that naturally calms traffic and manages stormwater. Ultimately, investing in these corridors is a commitment to the long-term livability and environmental resilience of the neighborhood.

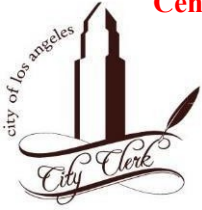
